

Domestic Student Fees 2022

For New Zealand Citizens, Permanent Residents and holders of New Zealand Business Visas. If the student is neither a NZ/Australian Citizen nor a NZ Permanent Resident please complete the 'International Students' Form. All amounts include GST.

ENROLMENT AND ENTRANCE COSTS

Application Fee

Payable at the time of submitting your application to cover administrative costs. This fee is non-refundable. \$250.00

Entrance Fee

The Entrance Fee is required as confirmation of acceptance of an offer of a place. This fee is non-refundable. \$900.00

Kristin Education Bond

A non-interest bearing bond will be payable upon acceptance at Kristin. This will be repaid after the student leaves Kristin, provided the appropriate notice has been given and all accounts are paid. \$3,000.00

ANNUAL TUITION FEES

Junior School (Years 0-6) \$19,300

Middle School (Years 7-10) \$23,840

Senior School (Years 11-13) \$23,340

Sibling Discount

A discount of 10% off tuition fees only, is given to the third sibling of families attending Kristin Junior-Senior School (excluding Little Doves Early Learning Centre and Kindergarten). This discount increases to 15% for the fourth and subsequent siblings attending Kristin.

Activity Fee

This fee covers all field trips associated with delivering the curriculum and varies across year levels. up to \$625

Development Contribution

This fee applies to a maximum of two students per family at any one time. \$1,150.00

ADDITIONAL FEES

Bus Fares

Digital Learning Programme

Junior School (Years 4-6) Bring your own (BYO) iPad (all apps are published on the website and are self-install)

Middle School (Years 7-10) Bring your own (BYO) laptop (majority of software is free or curriculum software)

Senior School (Years 11-13) Bring your own device (BYOD)

Kristin Alumni Association Fee

This \$500 one-off payment covers lifetime membership to the Kristin Alumni Association. This fee is non-refundable.

Uniform

New students can expect to pay approximately \$1,100 to obtain the full Kristin uniform. Second hand items are available through the KFF second hand uniform sales which can reduce this cost. Details of uniform requirements can be found [here >>](#)

Other Costs

Additional costs are charged to the school account for incidental items such as co-curricular activities, outdoor education (camp) and IB Diploma exam fees. These costs are communicated to families before being charged to a school account.

PAYMENT OPTIONS

Direct Debit Over 10 Months

Direct Debit Termly Instalments

Four equal instalments due on 20 February, 20 April, 20 July and 20 October.
